



**MINUTES OF THE

Agenda Items

1. Commander Honan reported that the County Directories printed. Advance copies were sent to all committee members and post commanders. However, it was discovered that, due to a misunderstanding, 115 names were dropped. Inserts with the missing names are being prepared and the balance of the directories will be distributed at the County Committee meeting on September 23rd.
2. Commander Honan reported that the post commander's planning meeting was poorly attended. Those who did attend shared the information about their posts' successes and failures. He believed that the concept is good and he hopes to continue with them in the future.
3. Commander Honan reported that the 2010 membership cards were distributed to most the posts at the county convention. The balance were mailed to the posts.
4. Adjutant Paul Schottenhamel reported that the county buried its first indigent veteran, Leonard Stevens, a Vietnam era Navy veteran, on August 7th. Services were provided by the George Werst Funeral Home in Glendale. Paul and Commander Honan were the only Legion members present. They escorted the body to the National Cemetery at Calverton. VFW Queens County Commander Marvin Jeffcoat attend the short wake. Two VFW motorcycle riders from Suffolk County came into the city and also escorted the body. City Councilmember Elizabeth Crowley, state assembly candidate Mike Miller, and Council candidate Tom Ognibene also attended. 104th Precinct Civilian Observation Patrol President Lou Kirchgessner and patrol member Kurt Berger provided an escort from the funeral home to the Jackie Robinson Parkway.
6. Adjutant Schottenhamel reported that the website has been improved. He encouraged all posts to submit flyers for post activities to be added on the Post Activities page. The minutes of the county meetings are all on the website.
7. Thomas Winberry reported on the activities at St. Albans.

The Pub at St. Albans was closed for the summer at the request of the hospital. He plans to reopen on Sunday, October 4th.
